### Conduct pre-donning checks and tests on breathing apparatus

- Breathing apparatus is inspected for immediate use in accordance with the organisation's procedures
- Faulty or damaged equipment is reported and recorded in accordance with the organisation's procedures

### Operate breathing apparatus

- Hazards are identified, monitored and controlled in accordance with the organisation's procedures
- Communication is established and maintained with members and other appropriate personnel throughout the activity
- Activities are undertaken as a member of a team, demonstrating effective application of breathing apparatus in accordance with the organisation's procedures
- Entrapment procedures are implemented in accordance with the organisation's procedures
- Personal safety is maintained at all times

### Conclude operations

- Breathing apparatus set is closed down in accordance with organisational procedures
- Breathing apparatus set is removed in accordance with the organisation's procedures
- After use cleaning and maintenance of breathing apparatus is undertaken in accordance with the organisation's procedures
- Equipment is made ready for operational use in accordance with organisational procedures.
